### **Attention : very limited capacity.**

If you have a registration authorization for the 2019 / 2020 academic year in a Higher Education establishment, you can apply for accommodation in a university residence with the CROUS of LILLE NORD PAS-DE-CALAIS.

Your student residence application must be filed online only. You must perform the two following operations:

**2/ After logging in on [messervices.etudiant.gouv](https://www.messervices.etudiant.gouv.fr), you can file your accommodation application by clicking on Find CROUS student accommodation (« Trouver un logement en résidence CROUS ») from July 09, 2020.**

- **students with a scholarship from the French authorities (BGF), from foreign authorities (BGE) based on agreements signed with the CNOUS and Campus France.**
- **Students from European mobility and inter-university exchange programs within the framework of agreements between the CROUS and Higher Education Establishments.**
- **Students enrolled in Post-Bachelor years**

### **LIVELIHOODS**

Please note that you must be able to meet your living expenses, either by means of a grant or sufficient personal resources (for information purposes only, you must have at least 615 euros monthly to meet your daily needs).

In addition, make sure that the regulations in force allow you to transfer funds from your country to France.

Attention: Owing to the current job situation in the North of France, as well as in the " Pas-de-Calais", students may find it very difficult to find even a temporary job.
